**Application for Rates Rebate: Social Security Grant / Disability Grant**

The Council's rates policy makes provision for rebates on property rates to persons with limited income under certain conditions.

Please attach the following documents (Copy of identity document, proof of monthly income AND the previous income tax year final assessment from SARS).

It is important to note that only a **Signed Form** together with all the relevant documentation (as mentioned in the Sections below) will be expected for further processing. Failure to provide the required documentation will result in the application not being approved.

**Conditions for application by persons in need of assistance in respect of property rating for the financial years 2008/2009**

- (i) the market value of the property as recorded in the prevailing valuation roll does not exceed R1 500 000.
- (ii) the property owner personally occupies the property.
- (iii) the maximum monthly income of the household from all sources may not exceed four times the National Security Grant plus R1.00 in order to allow the property rates rebate.
- (iv) the details required on the following pages must be verified by an affidavit and a person shall upon request furnish such further and or fresh particulars as may be required by the Council.

Applications together with supporting information must be returned to the Customer Relations Agents at your local Customer Care Centre for transmission to Thuso House.
